### Oversight of Child Care Moves to VDOE - House Bill 1012

- Early Childhood Unification Law (House Bill 1012) passed in the 2020 General Assembly and moved oversight of child care to the Virginia Department of Education.
- The Early Childhood Advisory Council was established to inform decisions made on regulatory changes for child care programs and make recommendations to the Board of Education.
- The Office of Child Care Health and Safety will continue regulating programs for health and safety requirements and carry out the vision for early childhood education in Virginia.
- The purpose of this webinar is to provide an overview of the changes made in the action to amend the Standards for Licensed Child Day Centers. More in -depth training will be provided for each region. A notice was sent to providers on August 6, 2021.



# Level -Setting and the Training Plan

- Child care subsidy fund recipients are already meeting most of the new requirements

# Standards for Licensed Child Day Centers (8VAC20 -780\*)

Action to Amend Standards for Licensed Child Day Centers to Address Federal Health and Safety Requirements

# Regulatory Process and Overview:

- Action to amend the Standards for Licensed Child Day Centers was initiated in 2015 by the Virginia Department of Social Services (VDSS).
- Amendments are limited to align requirements with federal requirements in the Child Care and Development Block Grant of 2014 (CCDBG). The regulatory process began in 2015-Notice of Intended Regulatory Action (NOIRA) Proposed Regulation
- Over 1,000 public comments were received on the proposed regulation.
- The final draft was approved by VDSS in 2018, as well as the Governor in 2021. The regulation was adopted by the Virginia Board of Education 2021.



# Regulatory Process and Overview:

- Regulation becomes effective on September 21, 2021.
- The final draft available on Virginia Regulatory Town Hall reflects the regulation under the Board of Social Services, 22VAC40-185. The regulation that becomes effective on September 21, 2021 will be 8VAC20-780, under the Board of Education, and include all of the changes.

# 2014 Child Care and Development Block Grant (CCDBG) Included the following Health and Safety Topics::

- Preventing the spread of disease
- Prevention of sudden infant death syndrome and use of safe sleeping practices
- Administration of medication
- Prevention of and response to emergencies due to food and allergic reactions
- Building and physical premises safety
- Prevention of shaken baby syndrome and abusive head trauma
- Emergency preparedness and response planning
- Handling and storage of hazardous materials and the appropriate disposal of biocontaminants
- Precautions in transporting children
- First Aid and CPR



# Substantive Changes- Topic Areas

- Reports and Records
- Tuberculosis Screening
- Immunization and Physical Exam Requirements
- Prevention of and Response to Food and Allergic Reactions
- Prevention of Shaken Baby Syndrome and Abusive Head Trauma
- Emergency Preparedness
- Orientation
- Annual Training
- Group Size and Supervision
- CPR and First Aid
- Staff age requirements



# New Substantive Changes: Reports and Records

- Requires a written record of a child in attendance as arrival and departure occurs for each group of children. (8VAC20-780-80)
- Providers must contact the department when child care services have been suspended or terminated for more than 24 hours as a result of an emergency situation, and when care is resumed. (8VAC20-780-80)
- Providers must contact the department as soon as practicable but not to exceed two business days of an injury to a child in care that requires outside medical attention. (8VAC20-780-80)



# New Substantive Changes: Tuberculosis Screening

- Documentation of tuberculosis screening to be submitted at the time of employment and prior to coming in contact with children. (8VAC20-780-160)
- Tuberculosis screening must have been completed within 30 calendar days prior to employment. (8VAC20-780-160)



# New Substantive Changes: Immunization and Physical Exams

- Establishes 90 day grace period for immunization/physical exam requirements for homeless children and children in foster care. (8VAC20-780 130 and 8VAC20-780-140)
- Documentation of enrollment of homeless children and children in foster care required in the child's file. (8VAC20-780-60)



# New Substantive Changes: Prevention of and Response to Emergencies Due to Food and Allergic Reactions

- Staff must be informed of children's allergies, sensitivities, and dietary restrictions (8VAC20-780-40)
- List of allergies, sensitivities, and dietary restrictions is required in each room or area where children are present (8VAC20-780-40)
- A written care plan must be in the child's record and taken while transporting children (8VAC20-780-60 and 8VAC20-780)
- The provider must notify the parent of a confirmed or suspected allergic reaction and ingestion or contact with a food identified in the written care plan. (8VAC20-780-550)
- Requirements added to avoid cross-contamination.(8VAC20-780-560)



# New Substantive Changes: Prevention of Shaken Baby Syndrome and Abusive Head Trauma

- Written procedures required for prevention of shaken baby syndrome or abusive head trauma, coping with crying, safe sleep practices and sudden infant death syndrome. (8VAC20-780-40)
- Orientation training on shaken baby syndrome is required. (8VAC20-780-240)

\*Clarification- Abusive head trauma is physical child abuse that results in an injury to the brain of a child. Even if your program does not serve infants and toddlers, young children are subject to the impact of abusive head trauma.



# New Substantive Changes: Emergency Preparedness

- Procedures required for relocation, lockdown, fire, severe storms, loss of utilities, and violence at or near the facility. (8VAC20 -780-550)
- Annual lockdown drills are required. (8VAC20 -780-550)
- Accommodations or special requirements for infants, toddlers, and children with special needs to be included in emergency plan. (8VAC20 -780-550)
- A procedure to reunite children with their parent is required. (8VAC20 -780-550)



# New Substantive Changes: Emergency Preparedness

- Procedures required for parents/guardians to pick up their child in the event of a man -made disaster. (8VAC20-780-550)
- Continuity of operations to be included in the emergency preparedness plan. (8VAC20 -780-550)
- Orientation and annual training on emergency preparedness is required. (8VAC20 -780-240 and 8VAC20-780-245)
- Volunteers who work more than six hours per week must receive training on the center's emergency procedures within the first week of volunteering. (8VAC20 -780-240)



# New Substantive Changes: Orientation Training

New Orientation training to be completed within 7 days of assuming job responsibilities (\*unless otherwise noted):

- Virginia Department of Education
   Orientation Course Better Kid Care Preservice (\*within 90 days)
- Center Policy on Administering Medication
- Infection Disease Prevention and Control
- SIDS Prevention and Safe Sleep
- Shaken Baby Syndrome Prevention

(8VAC20-780-240)

- Emergencies Due to Food and Allergic Reactions
- Precautions in Transporting Children
- Emergency Preparedness and Response Planning
- CPR and First Aid (\* training only, within 30 days)



# **New Substantive Changes: Annual Training**

Annual training relevant to staff's job responsibilities and the care of children, must include topics such as:

- Child Development
- Behavior Management
- Infection Disease Prevention and Control
- SIDS Prevention and Safe Sleep
- Shaken Baby Syndrome Prevention
- Emergency Preparedness and Response Planning
- CPR and First Aid (Training only)
- Precautions when Transporting Children

(8VAC20-780-245)

- Allergy Emergency Prevention and Response
- Center Policies and Procedures on Administering Medication
- Building and Physical Premises Safety
- Signs and Symptoms of Child Abuse and Neglect
- Handling and Storage of Hazardous Materials
- Care Recommendations for Children with Special Needs



### New Substantive Changes: Group Size and Supervision

- Group size means the number of children assigned to a staff member or team of staff members occupying an individual room or area. (8VAC20-780-10)
- Requires licensees to formulate and implement a plan to ensure that children receive care by consistent staff. (8VAC20 -780-350)
- Institutes new group size restrictions that establish the maximum number of children that can be assigned to the care of a staff member or team of staff members. (8VAC20-780-350)



# New Substantive Changes: CPR and First Aid Certification

- Requires at least one staff member who is CPR/First Aid -certified to be in each classroom or area where children are present within 90 days (8VAC20 -780-530)
- At least two staff certified in CPR and First Aid must always be present at the center wherever children are in care (8VAC20 -780-530)

\*Note: all hours of CPR and First Aid certification training count toward annual training hours

• CPR and First Aid orientation and annual training is a lower level of training than certification. There is flexibility on how this training is obtained and the specifics of what is covered. More information will be provided in the training.



# New Substantive Changes: Staff Age Requirements

- Staff who administer medication must be 18 years or older (8VAC20 -780-510)
- Staff who transport children to be 18 years of age or older (8VAC20 -780-580)
