

REGISTER FOR A CENTRAL REGISTRY SYSTEM ACCOUNT

Quick Reference Guide (QRG)

OVERVIEW

AUDIENCE

This QRG provides an overview of how to register for a Central Registry account within the OBI web-based portal in order to submit Central Registry Search (CRS) requests and Portability requests. This QRG is for VDOE Providers, including child care providers, school systems, Head Start programs, and other educational based programs. VDOE Providers should select DOE User type when registering for a Central Registry System account.

About Registering for an Account: The <u>OBI Portal</u> is accessed via the DSS website and is a public-facing site allowing providers, government agencies, and individuals to complete and submit a Central Registry Search request and submit a payment for the application being submitted.
