**Subject:** Child Care Subsidy Program Copayments Resuming January 1

## Message text:

Dear Child Care Subsidy Provider,

Beginning January 1, 2023, copayments will resume for families enrolled in the Child Care Subsidy Program (CCSP). Copayments will be calculated using a new, simplified scale that is based upon a monthly per-child rate. Federal law requires most families in the CCSP to pay a copayment to their child care provider. During the pandemic, the federal government provided flexibility and Virginia temporarily covered all copayments. This flexibility, however, will end on December 31, 2022 and Virginia must begin to charge copayments again. **No copay should be collected from families before January 1**.

In early December, notices will be printed and mailed to notify families of their copayment amounts due beginning in January 2023. Also in early December, Subsidy Vendors will be sent new Purchase of Service Orders (POSO). We are sending POSOs through an incremental process. Vendors should receive all POSOs by December 21, 2022.

Using the new copayment scale, the family's copay will be applied to authorized services on a per child basis. Viewing the per child amount is important for vendors to determine the total copay owed to the vendor. For this reason, it is important that vendors keep their paper copy of their POSOs on file.
